



**REGULATIONS FOR THE TRIP OFFER IN EXCHANGE OF
THE PURCHASE OF AIR PUMP
DURING OCTOBER 15TH 2011 TO DECEMBER 31ST 2011**

Art. 1 : ORGANISATION

AIRWELL FRANCE SAS (hereinafter called Airwell), a French company with a capital of 5.000.000 Euros, registered under the number R.C.S. 421 305 996, whose registered office is located at 1 bis Avenue du 8 mai 1945, 78280 Guyancourt France, offers the trips detailed below to any installer and / or distributor (hereinafter the Participants) which will purchase 10 (ten) heat pumps (HT and Aqu@Advance split and Monobloc) during the period from October 15th to December 31st 2011.

This offer begins October 15th and ends in December 31st 2011, provided that the corresponding invoices related to said purchases are sent to our company before January 13th 2012, in the same mail at the address mentioned on the leaflet.

The journeys shall be booked between January 15th 2012 and April 30th 2012 (excluding French school holidays).

Art. 2: CONDITIONS FOR PARTICIPATION

This Offer is reserved to the Participants who comply with the conditions of stay of the countries where the trips are organized.

It will be up to the Participants to verify these conditions of stay, to take all necessary actions to comply with these conditions of stay and to bear the cost relating to these conditions of stay.

For the weekends in New York, in particular, the Participants must complete the ESTA form by himself before the departure and bear the cost.

The same conditions apply to people travelling with the Participants.

Airwell can not be held liable if any of the Participants and/or the people travelling with them do not comply with the conditions of stay of the countries where the journeys are organised.

Delays, cancellation and additional expenses resulting from the non compliance with the conditions of stay of the countries where the trips are organized will not be supported by Airwell.

Art. 3: TERMS OF THE OFFER

a) Application :

Participants must send their application in the same one (1) mail before January 13th 2012 (as attested by the date on postmark) at the following address:

The application must content :

- Full name,
- Complete address,
- Phone number,
- E-mail address,
- Copies of all the invoices received during the period describe above,
- Serial numbers of the heat pumps purchased.

Each invoice can only be used once for the Offer. Only one (1) mail and one (1) Application by Participant will be taking into account.

Incomplete application will be considered non valid and refused.

One (1) trip only will be attributed to each Participant with a complete application in the limit of the trips available.

b) Upon receipt of a complete application, Airwell will answer within one month (after receipt) to the Participants with valid application, and forward their application to the travel agency who will contact them for the trip arrangements.

The trips will be attributed to each Participant within the limit of available places for each trip.

Art. 4: TRIPS

In the limit of available trips the Participant, with a complete application, will choose the trip and the date he wants to leave knowing that departure must occur between January 15th 2012 and April 30th 2012.

The Travel agency will make its reasonable efforts to meet the Participant request.

The mean value of the trip is € 2.500 including taxes. In the event where, for whatsoever reasons, the Participant can not book a trip he will not have the right to ask for any financial counterpart.

Documents and/or photos relating to the trips have no contractual value. Airwell has the right to replace, at any time, any trip by a trip of an equivalent value or close characteristics.

Airwell can not be held liable for delays and / or loss of mails due to postal services, or for any other case. Airwell can not be held liable for any mistakes made by the Travel agency that may conduct to the delay or the cancellation of a trip.

The trips are named specific, thus they cannot be attributed to another person than the Participant.

Art 5: ADVERTISING

Airwell has the right to publish on whatsoever support, for the purposes of advertising, or any other worldwide communication campaign, the name and/or the photo of the Participants who can not refuse this publication or ask for any counterpart, unless giving up their application for the trips.

The Participants expressly agree with the content of this article.

Art 6 : DATA PROTECTION

Pursuant to the French Regulation (loi n° 78-17 du 6 janvier 1978 informatique, fichiers et libertés) the Participants have the right to refuse the publication of their personal data (art. 26) and to access (art. 34 à 38), modify and delete (art. 36) them.

Art 7: CORRESPONDENCE

No mails with an abnormality (incomplete, unreadable, wrong postage, sent by registered letter or registered letter with acknowledgement of receipt) will be taken into account.

Airwell will not answer to any requests (written, phone or verbal) regarding the interpretation and/or the implementation of this regulation, the modalities and the mechanisms of the Offer.

Art 8 : LIMITATION OF LIABILITY

Airwell shall not be held liable for any cancellation or whatsoever modification of one or more trips due to an act of God as defined by French law.

Airwell shall not be held liable for any direct or indirect loss due to or caused to any Participant, or the people travelling with them, during the trip.

The Participants and the people travelling with them join the trip at their own risk. Airwell has the right to prosecute any Participants who has cheated or tried to do so.

Airwell can not be held liable for any delay in the routing of the mails.

Art 9 : ACCEPTANCE OF THE REGULATION

The application for this Offer implies the acceptance of the provisions of this regulation and the acceptance of the decision of Airwell regarding any protest due to the interpretation and the application of the present regulation.

Art. 10 : EXCLUSION

Airwell may at any time, and without notice, cancel and/or refuse the application of any Participant who has not complied with the content of this regulation.

Airwell may at any time, and without notice, cancel and/or refuse any application presenting obvious errors as for the contact details and identity of the Participant.

Art 11 : INDUSTRIAL AND INTELLECTUAL PROPERTY

The reproduction, the representation and/or the exploitation of all or any elements illustrating the Offer are strictly forbidden.

All brands and Products names quoted in this regulation are registered Trademarks.

Their owners may take any legal action in order to preserve their rights from any kind of violation.

Art. 12 : DISPUTE

If one or more provisions of this Regulation are declared void or unenforceable, the remaining provisions shall remain in full force and effect.

All issues not planned by the present Regulation will be solved by Airwell without any possible contestation.

The Regulation is subject to French law. Any dispute arising from this Offer will be solved by a settlement.

In case no settlement can be found the competent court will be the Tribunal de commerce de Paris, in France.

No contestation can be raised more than 2 months after the closing of the Offer.

THE TRIPS PACKAGES

SKI IN FAMILY IN MERIBEL - RESIDENCE OF THE CRETS (for 4 persons)
